Court of stealing two pairs of stockings from a shop in Birmingham, to the value of 7s. 2d., when a fine of £10 was imposed.

A solicitor accompanied Mrs. Tomlin to the meeting of the Council, who pleaded for her on the grounds of very poor health and great domestic trouble.

GENERAL NURSING COUNCIL FOR SCOTLAND.

Sir John Lorne MacLeod, G.B.E., LL.D., Chairman of the General Nursing Council for Scotland, occupied the Chair, and 12 members of the Council were present at its meeting held at 18, Melville Street, Edinburgh, on January

Sir John Lorne MacLeod, G.B.E., LL.D., was unanimously reappointed Chairman of the Council, and Col. D. J. Mackintosh, C.B., M.V.O., Vice-Chairman for the ensuing

year. The existing Committees were reappointed.

A draft of the Annual Report to be submitted to the Department of Health for Scotland in terms of the Nurses' Registration Act was gone over and approved, along with the Auditor's Report on the Accounts for the year to December 31st, 1934.

The Report of the Education and Examination Committee was approved and in accordance with the recommendations of the Committee, it was resolved that in the case of Male Nurses trained in the Royal Air Force, the Council's Certificate of Instruction signed on behafi of the Air Ministry should be accepted.

On consideration of the results of the Examinations for last year, it was resolved that in the case of hospitals of whose Candidates more than a certain percentage had failed to pass the Council's Examinations during 1934, a communication on the subject should be sent to the Matron.

Detailed arrangements in regard to the February Examinations were approved, and it was reported that the names of a number of nurses who had already passed the Council's Examinations and had now attained the age of 21 had been placed on the Register.
