THE MATRONS' COUNCIL OF GREAT BRITAIN.

The Annual Meeting of the Matrons' Council of Great Britain was held at the House of the Royal British Nurses' Association, 194, Queen's Gate, London, S.W.7., on Saturday, March 14th, at 3.30 p.m. The President, Miss M. S. Cochrane, R.R.C., was in the chair, and there was a good attendance of members.

As this was the first time the members had met since the death of our late beloved King, the President invited the members to rise in silent tribute to His Majesty's memory. She reported that she had felt sure the Council would wish her to convey to Her Majesty Queen Mary its respectful sympathy, and its consciousness that the world had lost a great and beneficent influence, and this she did by telegram, without delay, and received the following telegram:—

. SANDRINGHAM, O.H.M.S.

"I AM COMMANDED TO CONVEY TO YOU AND ALL WHO

represented at the service held at Golders Green by the Hon. Treasurer, Miss Susan A. Villiers, J.P. She also reported that since the Council last met considerable progress had been made in regard to the Florence Nightingale International Foundation. The National Council of Nurses of Great Britain had already financed six Scholarships and proposed to award one for 1936-1937.

The Council had been represented at the Annual Meeting of the National Council of Women at Leicester in October by Miss E. T. Bickerton, R.R.C., and Miss M. Muriel.

Miss Farrant notified that she was not standing agan for election to the Executive Committee but was willing to represent the Council on the London Branch, Miss F. M. Campbell having resigned the position of Delegate of the Matrons' Council on the National Council Nurses, Miss Silvia Vian was elected to succeed her.

Miss S. A. Villiers presented the Hon. Treasurer's Report to the end of 1935, which closed the year with a small balance in hand.

Both reports were adopted.

Concerning the representation of the Matrons' Council on the National Council of Women, its representatives under the new scheme having been reduced from two to one, it was agreed to ask for information as to what had influenced the N.C.W. in making this reduction.

Miss Bickerton presented a very interesting report on the proceedings at the Annual Meeting of the N.C.W. at Leicester in October.

Mrs. Bedford Fenwick drew attention to the publication of the Report of the Scottish Departmental Committee presented by the Secretary of State to Parliament by command of His Majesty, and advised those present to study it.

She also reminded the Council that the International Congress of Nurses convened by the International Council of Nurses would be held in London in July, 1937, and that, as the hostess country, the National Council of Nurses of Great Britain was responsible for the financial arrange-
