"The Status of Women" Memorandum, as submitted to His Majesty's Government by the Special Committee of Women's Organisations convened by the National Council of Women of Great Britain, was presented and was placed on the table for the inspection of anyone desirous

RE-ADMISSION TO MEMBERSHIP.

An application was received from the Royal South Hants. Hospital Nurses' League, which had resigned some years ago, for re-admission; there was a precedent for this in the case of two other Leagues, but the President considered that in such cases there should be some formality to be conformed with, and the question should be considered by the Committee at a future date; at the present time the application of the Royal South Hants Hospital Nurses' League was in order, and it was agreed that it should be accepted.

RESIGNATION OF DULWICH HOSPITAL NURSES' LEAGUE.

The resignation of the Dulwich Hospital Nurses' League, which had been reorganised on the lines of a Social Club, with the Medical Superintendent of the Hospital as Presi dent, was accepted, as the constitution was not in conformity with the provisions of the National Council of Nurses' Constitution.

BRANCHES INELIGIBLE.

A letter from the Association of Scottish Queen's Superin tendents, Queen's Institute of District Nursing (Scottish Branch), asking for information as to their eligibility for membership of the Council, was considered. It was pointed

That there is no facility for the admission of Branches of Nurses' Organisations and that the Association of Scottish Queen's Superintendents be so informed.

REPORT ON THE FLORENCE NIGHTINGALE INTERNATIONAL FOUNDATION.

It was agreed that no Special Appeal should be made for the Florence Nightingale Scholarships' Fund on Florence Nightingale Thanksgiving Day, 1937, as there were already sufficient funds in hand in Great Britain for the Scholarship for 1937-1938, and the nurses, who had been most generous, and had contributed over £300 this year towards the Scholarship and £946 in support of the Congress Fund, would have many expenses in 1937 in attending the Congress and welcoming their colleagues from overseas.

THE REPORT OF THE HON. TREASURER.

The Hon. Treasurer presented her Report for the year together with the Audited Accounts and Balance Sheet, certificated as correct by the Auditor; it was received and agreed that the Report should be sent forward to the Annual Meeting.

The Committee then adjourned for tea.

On resuming, the next business considered was in relation to the International Council of Nurses.

The President presented a short Report of the Congress Arrangements Committee. In connection with this Report, Lloyd Still reported action concerning Dame Alicia arrangements for Divine Service on Sunday, July 18th,
