## Events of Public Importance.

By the death of His Majesty King George V on January 20th of this year, the British Empire sustained a great loss. By no section of his subjects was King George held in greater honour and affection than by the Nursing Profession. The King showed warm appreciation of the services of nurses, and personally decorated many of them as a mark of that appreciation.

A chaplet of flowers was sent to Windsor from the National Council of Nurses of Great Britain for King George's funeral and the following Address of Condolence to His Majesty King Edward VIII was forwarded through the Secretary of State for the Home Department.

## TO THE KING'S MOST EXCELLENT MAJESTY.

#### Most Gracious Sovereign,-

On behalf of the National Council of Nurses of Great Britain, comprising over 36,000 nurses, I desire to express to Your Majesty the deep sorrow of the members of this Council at the death of their beloved Sovereign King George V, of Blessed and Glorious Memory, and to humbly offer their most loyal and respectful sympathy in Your Majesty's irreparable loss.

The scrolls upon which these Addresses were inscribed were engrossed by hand on vellum parchment, their main features being the dignified lettering (based on Roman characters) in gold, purple and black, and tied with purple ribbon.

Gracious acknowledgments of these Addresses were received.

## ACKNOWLEDGMENT FROM HIS MAJESTY THE KING.

Home Office, Whitehall, March 17th, 1936.

Madam,-

I have had the honour to lay before the King the Loyal and Dutiful Address of the National Council of Nurses of Great Britain on the occasion of the lamented death of His late Majesty King George the Fifth, and have received the King's Commands to convey to you His Majesty's grateful thanks for the assurances of sympathy and devotion to which it gives expression.

The Proclamation on January 21st, 1936, by the Privy Council at St. James's Palace of King Edward VIII as King of these Realms was followed the next day by the Proclamation of His Majesty in London and throughout the Empire "as our only lawful and rightful Liege to whom we do acknowledge all faith and constant obedience with all hearty and humble affection," a declaration of fealty right heartily accorded to a Prince who had already won the affection of the nations associated in the British Empire by his charm, sincerity, simplicity, and Royal gift of service.
