Of Miss Margaret B. Vickers, delegate on the Grand Council of the

on the Grand Council of the Bradford Royal Infirmary Nurses' League. Of Miss M. V. Lindall, delegate on the Grand Council of the College of Nursing. Of Miss Alice Simpkin, for many years a much valued member of the staff of the Universities' Mission to Central Africa

The deaths of these four nurses are a great loss, as their work in different departments of nursing was of exceptional value, demanding the highest type of intelligence and feeling.

Mrs. Andrews did pioneer work as an Inspector under the Local Government Board of maternity wards, nurseries and nursing arrangements in Poor Law Institutions; and Miss Simpkin devoted her skill and talents for many years to the service of the natives of Central Africa in connection with the Universities' Mission

The Report from the Executive Committee was received with applause, and was adopted.

REPORT OF THE HON. TREASURER.

Miss M. Breay, Hon. Treasurer, presented the Audited Accounts and Balance Sheets of the three funds administered by the National Council of Nurses.

Miss Breay said:-

I have the honour to report in connection with the audited accounts for the year ending September 30th, 1936, that we

close the year with a balance in hand of £30 8s. 6d., of this £17 3s. 10d. is for sums due for the year 1936-1937, our actual balance is therefore £13 4s. 8d.

It is satisfactory to note that every affiliated Association has paid its annual dues to the National Council of Nurses, and its per capita contribution to the International Council of Nurses, amounting to £618 19s. 2d., and we have received a welcome donation of £5 from the Nightingale Fellowship.

In addition the affiliated Associations have contributed most generously during the year to the Florence Nightingale Scholarships Appeal Fund, and the International Congress of Nurses Expenses Fund. To the Scholarships Fund they have contributed during the year £268 6s. 4d.,

which with a balance in hand from last year of £39 14s. 0d., £28 0s. 0d. received since the audit, and interest on deposit £1 13s. 0d., makes £337 13s. 4d.

In regard to the International Congress of Nurses Fund in response to our appeal for £1,000 to meet the estimated expenses, in addition to the amount to be received later for Congress tickets, we have received, in cash during the period March 12th to September 30th, £595 6s. 0d., and since the accounts were closed for audit on that date £60 18s. 0d., making £654 4s. 0d. We have also received promises amounting to £290, making a total of £946 4s. 0d.

Thus owing to the generosity of our Affiliated Associations and other interested members of the nursing profession, we can face our responsibilities in the coming eventful year with equanimity.
