APPOINTMENT OF REGISTRAR, THE GENERAL NURSING COUNCIL FOR SCOTLAND. RESOLUTION.

"That the Council of the British College of Nurses is unanimously of opinion that in the interests of the Nursing Profession the time is now relevant when a Registered Nurse should be appointed to fill the office of Registrar to the General Nursing Council for Scotland. Such a professional appointment would appear to be the more equitable as Registered Nurses provide the emoluments for the maintenance of the office of Registrar."

APPOINTMENT OF REGISTRAR.

The important position of Registrar to the General Nursing Council for Scotland is now vacant, particulars of which will be found in our advertisement columns. Upon the passing of the Nurses' Registration Acts in 1919, the claim was at once advanced by the Nurses' representatives upon the General Nursing Council for England and Wales, that a Registered Nurse should be elected to this important professional post. This claim was recognised as sound and Miss M. S. Riddell, R.R.C., was appointed Registrar, and held the position until 1933, when upon resignation on pension she was succeeded by Miss G. E. Davies, S.R.N.
