# THE BRITISH COLLEGE OF NURSES.

## REPORT OF THE COUNCIL MEETING.

A Meeting of the Council of the British College of Nurses was held on Saturday, June 19th, 1937, at 39, Portland Place, London, W.1, at 2.30 p.m.

The President, Mrs. Bedford Fenwick, was in the Chair,

#### The Minutes were confirmed and signed.

RETIRING MEMBERS OF THE COUNCIL. The President, on rising, stated that having completed their term of Office on the Council it was with very sincere regret that it would lose the very valuable expert services of the retiring members, Miss F. M. Campbell, Miss E. L. Macaulay, Fellows, and Miss E. F. Eburah, Member, and proposed that a warm vote of that so for their loyal help during their period of office should be conveyed to them, which was carried unanimously.

#### BUSINESS ARISING.

It was reported that letters had been received:—(a) From Miss Elizabeth Brodie, stating that she has received the official information that she has been appointed to the Council of the British College of Nurses with great pleasure, and stating she was prepared to serve the College and take an interest in its work. The Chairman reminded the meeting that Miss Brodie had previously served on the

Council, greatly to its advantage.
(b) From Miss Dorothy D. Tilby, saying that she feels honoured that the Council has nominated her for office as a member of the Council in place of Miss F. M. Campbell, that she will do her best to justify the confidence placed in her by the Council, and will be happy to serve at any

time in any way.
(c) From Miss Dorothy M. Dickinson, stating that she has much pleasure in accepting the invitation of the Council to represent the Members on the Council of the British College of Nurses, and that she has been appointed Matron of St. Mary's Hospital for Women and Children, Plaistow. It was directed that a letter be sent to Miss Tilby, Fellow,

and Miss Dickinson, Member, that their nominations to the Council were unanimously confirmed.

Letter from G. H. Gater, Esq., Clerk to the London County Council, stating the relevant conditions to the Council's consent for the use of the buildings (35 and 37, Portland Place, St. Marylebone), as headquarters for the International Broadcasting Company, which are as follows:

1. The external appearance of the premises fronting

Portland Place being maintained in all respects as that of

private dwelling houses.

2. No injury to the amenities of the area being caused by the use of the premises and no disturbance of occupiers of adjoining premises being caused by noises or apparatus in the building.

3. No signs or advertisements other than a small brass or similar name-plate being exhibited on the premises.

Letter from Miss P. Oakley Williams, of thanks for nice letter, also for the appreciation of the Statuette of Florence Nightingale she gave to the College through Miss Mac-

donald, in The British Journal of Nursing.

Letter from Miss E. L. Macaulay, O.B.E., R.R.C., of thanks for sympathy conveyed to her from the Council concerning her accident, and stating that she will soon be allowed to travel, and looks forward to visiting the College

in the near future.

#### CORRESPONDENCE.

Letter from Miss D. Bignell, M.B.C.N., stating that she has been appointed Matron of the Infectious Diseases Hospital, Dartford, Kent, and asking if there is a book on Hospital Organisation that can be recommended. "Nursing," by Miss M. S. Cochrane, R.R.C., and other books were advised.

Letter from a Matron asking for advice re a nurse's claim for salary and holiday allowance, stating that she left to take up another appointment. She had been on duty less than nine months, and expected part of salary and board allowance for an annual holiday, and the question had never arisen before. Reply drafted. Submitted and approved.

Letter from Miss Marjorie Watts, of the National Council

It was unanimously agreed to communicate with a member, inviting her to act as the College representative at the Conference to be held at Bournemouth.
