THE GENERAL NURSING COUNCIL FOR ENGLAND AND WALES.

The meeting of the General Nursing Council for England and Wales was held at the offices of the Council, 23, Portland Place, London, W., on October 22nd.

The Chairman, Miss E. M. Musson, C.B.E., R.R.C., LL.D., presided. The Chairman reported that the Minister of Health had

sanctioned the additional staff applied for.

Correspondence.

The Chairman reported correspondence from the President of the Board of Education, intimating that a Committee was being set up to consider Recruitment, Training and Employment of persons in the Nursing Profession, with the Earl of Athlone as Chairman, and requesting that a representative be appointed for the General Nursing Council for England and Wales to serve on this Committee.

Miss R. Cox-Davies, C.B.E., R.R.C., proposed, Miss M. E. Sparshott, C.B.E., R.R.C., seconded, and it was agreed that Miss E. M. Musson be appointed as the representative of the General Nursing Council on this Committee.

Finance.

On the recommendation of the Finance Committee, bills and claims submitted for payment were approved, and the sums of £11,000 for examiners' claims and expenses, \pounds 1,000 for accommodation for examinations, \pounds 150 for postage stamps, $\pounds 50$ for insurance stamps, and $\pounds 20$ for petty cash were allowed.

Registration.

Applications for approval for Registration on October 22nd, were : General Register, by reciprocity, 18; Supplementary part of the Register for Sick Children's Nurses, by reciprocity, 1; for Fever Nurses by Examina-tion 13, by reciprocity, 6; total, 38.

On the recommendation of the Registration Committee, it was agreed that 56 nurses who had hitherto failed to pay their retention fee, and now wished their names reincluded in the Register, should be re-included.

It was agreed that Recommendation 3 passed by Council on February 26th, 1937, be amended as follows :-

Clause 1, lines 1 and 2.—By the substitution of the words " in not more than two General Hospitals in India" the words "in a General Hospital in the Presidency of Bombay, excluding Sind ";

Clause 2, line 2.—By the insertion of the words "in India" after the words "General Hospital"; and by the insertion of the following Clause :—

"2 (a). Applications from nurses trained in General Hospitals (see Note) in India and registered in accordance with proviso 3, rule 9, of the Bombay Nurses', Midwives' and Health Visitors' Rules will be considered on their respective merits."

Education and Examination.

On the recommendation of the Education and Examination Committee, it was agreed that the Surrey County Hospital, Redhill, be provisionally approved as a complete training school for nurses for a period of one year; and that the scheme of affiliation between the Caerphilly Isolation Hospital and the Cardiff City Isolation Hospital be provisionally approved for a period of one year.

General Purposes.

On the recommendation of the General Purposes Committee, it was agreed that the following equipment be purchased :---

Disciplinary Cases.

The Solicitor for the Council placed the following cases before them :-

Miss Gladys Kaye, S.R.N. 35763, R.F.N. 3389, was charged at the West London Police Court with stealing a clock value 8s. 6d. from a London store. She pleaded guilty and was bound over in a sum of f_{10} , placed under the supervision of a probation officer for 12 months, and fined f_{10} 10s. costs.

The Council considered the case in camera, and decided to remove from the Register of Nurses the name of Gladys Kaye, S.R.N. 35763, R.F.N. 3389.

Miss Ellen Todd, S.R.N. 46746, was charged with stealing skeins of silk from a store, and was discharged under the Probation of Offenders Act.

The Council considered this case, and it was decided to defer judgment for a period of one year.

Next Meeting of the Council.

The next meeting of the Council was fixed for Friday November 26th.
