## THE LONDON COUNTY COUNCIL'S **MIDWIFERY SERVICE.**

The Minister of Health has approved the London County Council's proposals for the setting up of a domiciliary service of midwives in London. The scheme will come into operation on January 1st next, the earliest possible date.

The Hospitals and Medical Services Committee is taking steps to appoint the 42 whole-time salaried midwives to be engaged by the Council for the purposes of the scheme. In addition to the midwives to be appointed directly by the Council, a minimum of about 120 wholetime midwives will be employed by arrangement with upwards of 40 voluntary organisations.

When the new scheme comes into operation every London mother, irrespective of her financial circumstances, will be able to call on the services of a fully-qualified midwife.

Officer of Health for the City of Stoke-on-Trent, regarding the practice of midwives in his area who are in the habit of notifying births to a particular insurance society and receiving payment for same, and enquiring whether there is any rule forbidding midwives from carrying on this practice.

On the recommendation of the Standing Committee the Board agreed:

That the Medical Officer of Health for Stoke-on-Trent be informed that although the Rules of the Board do not specifically forbid midwives to notify births to an insurance society, the Board is of the opinion that midwives should aim at a standard of conduct which increases rather than diminishes the dignity of their profession and that from this point of view the practice of midwives notifying births

to an insurance society is to be deprecated. 5. The Committee considered applications for the approval of the following institutions for the purpose of providing instruction in the essentials of obstetric analgesia and in the use of a recognised apparatus :--

6. The Committee considered a report from the Secretary regarding the regulations for the Midwife-Teachers Examination.

The Board agreed to the recommendations of the Committee:

That the existing regulations which the Board decided should apply to the Examinations to be held in 1936 to 1938 inclusive should be continued for the year 1939.

7. The Secretary reported that he had placed on the Roll the names of 39 women holding the Certificate of the Central Midwives Board for Scotland, the Joint Nursing and Midwives Council for Northern Ireland, the Central Midwives Board for the Irish Free State or the Nurses' Registration Board for New South Wales, as the case might be.
