MUTUAL CONGRATULATIONS.

The Editor of THE BRITISH JOURNAL OF NURSING has received from the Registrar of the General Nursing Council for the Irish Free State an expression of "the Council's deep appreciation of the Article on the Publication of the Results of the Council's Examination in the Irish Free State. It made very pleasant reading."

We are hoping the progressive policy in this particular adopted in the Irish Free State will be followed at an early date in England and Scotland. Nothing would give our Registered Nurses greater satisfaction after all their hard work than such public recognition.

ENGLAND AND SCOTLAND MUST LOOK TO THEIR LAURELS.

It will be remembered that on October 2nd, 1934, the Council of the British College of Nurses, on the initiative of Miss M. S. Cochrane, adopted unanimously and sent the following resolution to the General Nursing Council for England and Wales :—

"That the General Nursing Council for England and Wales be requested to publish in the general Press the names of successful candidates in the Final State Examinations, as is the custom of other Statutory and Professional Bodies."

At a meeting of the G.N.C. on October 26th it was reported that to publish the results of the examination in one paper would cost £300 a year and that was a specially reduced fee.

It was proposed by Dr. Collins, seconded by Miss Sparshott, that the Resolution be laid upon the table in other words, be not considered and treated with contempt.

Presumably this autocratic attitude was reconsidered, as at its meeting on November 17th, a reply was received from the General Nursing Council expressing the opinion that : "In view of the fact that each candidate receives an individual notification, it was decided that such publication was not necessary. On enquiry, moreover, it was found that to publish the names would be exceedingly costly."

A letter was then addressed by the British College of Nurses to the Council deprecating an attitude of indifference to the Registered Nurses' Professional Status, both in laying the letter addressed to it on the table and in its decision to take no action.

COST OF EXAMINATION.

The fact that to conduct a recent examination cost $\pounds 10,000$, that thousands have been spent in erecting palatial Headquarters in Portland Place, London, and that at its recent meeting the Council agreed to spend $\pounds 10,000$ in furnishing the same—every penny of which the Registered Nurses provide,—inspires us to express the hope that following the example of the Irish Free State Council, $\pounds 300$ of their own money may be forth-coming to benefit the nurses individually—by giving publicity in the Press to their professional attainments, is the hope of sanguine progressives in the nursing world.

THE BRITISH COLLEGE OF NURSES.

Prayers having been read, the Minutes of the last meeting were read and confirmed and signed.
