GENERAL NURSING COUNCIL FOR SCOTLAND.

A Meeting of the General Nursing Council for Scotland was held at the offices of the Council, 18, Melville Street, Edinburgh, on Friday, February 26th, 1937. Sir John Lorne MacLeod, G.B.E., LL.D., occupied the Chair. Apologies for absence were intimated from Miss Merchant and Miss Milnes.

Report of Uniform Committee.

The Report of the Uniform Committee was submitted, and it was stated that the Committee had considered specimens of the State Registered Nurses' Hats, models A and B, as recently approved by the General Nursing Council for England and Wales, and on the recommendation of the Committee the Council agreed that the new models should be approved.

Report of Education and Examination Committee.

The Report of the Education and Examination Committee was submitted. The name of Miss Barbara H. Moir, Aberdeen, was added to the Council's Panel of Examiners for the Preliminary Examination in the subjects of Theory and Practice of Nursing, Part I, and the name of Dr. R. C. M. Pearson, Edinburgh, was added to the Panel of Examiners for the Final Examination in the subjects of

the First Paper in Fever Nursing.

The names of a number of Nurses who had already passed the Council's Examinations and had now attained the age of 21 were reported as placed on the Register.

Report of the Finance Committee.

The Report of the Finance Committee was submitted and sundry accounts were passed for payment.

HER MAJESTY THE QUEEN AND THE ST. JOHN AMBULANCE BRIGADE.

It is officially announced that Her Majesty the Queen has graciously been pleased to retain her appointment as Commandant-in-Chief of the Nursing Corps and Divisions of the St. John Ambulance Brigade.

Her Majesty, who is a Dame Grand Cross of the Order of St. John, has always taken a keen and active interest in the work of the Brigade, and has held her present appointment since May, 1928.

PROTECTING THE "TODDLER." THE TODDLER STAGE.

Sir Arthur MacNalty, the Chief Medical Officer of the Ministry of Health, referred to the possibility of reducing mortality and sickness among young children at the "toddler stage," in an address delivered at the opening of a new Maternity and Child Welfare Centre at Hornsey

The decline in the rate of infant mortality for England and Wales as a whole had been a source of satisfaction to all concerned with infant welfare, said Sir Arthur. The success which had been achieved in the reduction of infant mortality gave ground for hope that in due course a corresponding advance might be made in protecting children in the next important stage of life—the "toddler" stage—from those impairments which could be avoided or mitigated by careful supervision.

Here, continuity of medical supervision, before and after school age was reached, was of much importance, and called for a maximum degree of co-ordination between the Maternity and Child Welfare Service and the School

Sir Arthur said that he was pleased to see that in Hornsey such co-ordination existed in the fullest measure, and he congratulated the municipality on its excellent record in the field of Maternity and Child Welfare.
