# THE GENERAL NURSING COUNCIL FOR ENGLAND AND WALES.

A meeting of the General Nursing Council for England and Wales was held at the offices of the Council, 23, Portland Place, London, W.1, on July 22nd. Miss E. M. Musson, C.B.E., R.R.C., LL.D., presided.

#### Business arising out of the Minutes.

It was reported that Miss Anstruther Sinclair was fined  $\pm 5$  for falsely representing herself to be a State Registered Nurse. She did not appear in Court, but wrote apologising for the offence and promising not to do it again. The Chairman considered she had been very leniently dealt with, as she had been prosecuted before, and had served two months' imprisonment.

The Chairman reported that the Minister of Health had sanctioned the appointment of additional staff for the work in connection with the Test Educational Examination.

The Chairman reported that she had attended a meeting of the Women's Voluntary Services as the representative of the General Nursing Council, but had found that the work of the Committee was not in any way connected with State Registered Nurses, but was more particularly concerned with cooks, ward maids, etc. She proposed that the representation of the General Nursing Council be withdrawn, which was agreed.

#### Correspondence.

"That the Matrons' Council of Great Britain desires to place on record its strong disapproval of the action taken at a meeting of the General Nursing Council for England and Wales by which a resolution was passed to split the Preliminary Examination of Nurses."

It was agreed that its receipt be noted.

Miss Helen Dey asked if the knowledge were available of how many members there were in the Matrons' Council. The Chairman replied that it was not.

#### Finance.

On the recommendation of the Finance Committee, bills and claims submitted for payment were approved, and the sums of  $\pounds 250$  for postage stamps,  $\pounds 500$  for postage for retention fee policies and receipts,  $\pounds 70$  for insurance stamps, and  $\pounds 20$  for petty cash were allowed.

It was reported that in accordance with authority granted by Council on June 25th, 1937, £4,500 5 per cent. conversion loan stock had been sold at 113  $\frac{11}{12}$  per cent.

#### **Registration.**

It was reported that a copy of the Register of Nurses had been received from the General Nursing Council for Ireland and the Nurses' Board of South Australia.

It was reported that reciprocity had now been agreed with the Department of Health, Ontario.

Applications for approval for registration on July 22nd were: General Register, by reciprocity, 27; Supplementary Part of the Register for Mental Nurses, by reciprocity, 1; for Sick Children's Nurses, by reciprocity, 1; for Fever Nurses, by examination, 13, by reciprocity, 5; total, 47.

It was agreed that 26 nurses who had hitherto failed to pay their retention fee and now wished their names reincluded in the Register should be re-included.

### Education and Examination.

On the recommendation of the Education and Examination Committee, it was agreed that :--
