by a special Committee. The following resolution was ultimately adopted:----

"That the Constitution of the National Council of Nurses of Great Britain shall not be amended in Sections, but a Special Sub-Committee, consisting of not more than nine members and the Hon. Officers, shall be appointed to consider the Constitution as a whole and make recommendations to the Executive Committee. The Executive Committee shall be specially summoned at an early date."

It was agreed that it be reported to the Grand Council that the Executive Committee recommended that a Special Sub-Committee be formed to deal with the matter.

A vote of thanks was proposed to the Chairman, which was carried with acclamation.

The meeting then terminated.

Tea was served by the invitation of the President.

THE NURSES' ORGANISATIONS.

LEAGUE OF MENTAL HOSPITAL NURSES.

The annual meeting of the above League was held at Middlesex Colony, Shenley, Herts, on Saturday, October 22nd, and members from various parts of England were present. The chairman and medical superintendent received the members and wished them a successful meeting. Various new members were elected to the Committee, and it was approved that Mrs. Lediard, S.R.N., R.M.N., D.N. Lon., M.B.C.N., should be supported as candidate for directorship in the coming election of the National Council. It is hoped that all mental nurses will support this nomination in November.

Mrs. Lediard, Chairman of the League, has been mental nursing for 27 years in various capacities, from nurse to sister-tutor and matron, and was delighted to entertain the members at the Colony. She expressed the wish that all Mental Nurses should join the League and thus support the success of their own profession. THE GENERAL NURSING COUNCIL FOR ENGLAND AND WALES.

A Meeting of the General Nursing Council for England and Wales was held at the Offices of the Council, 23, Portland Place, London, W., on October 28th, the Chairman, Miss E. M. Musson, C.B.E., R.R.C., LL.D., presided.

Finance.

On the recommendation of the Finance Committee, bills and claims submitted for payment were approved, and the sums of $\pounds 11,000$ for Examiners' Claims, $\pounds 1,000$ for accommodation for examinations, $\pounds 250$ for Postage Stamps, $\pounds 50$ for Insurance Stamps, and $\pounds 20$ for Petty Cash were allowed.

Registration.

It was reported that a copy of the Register of Nurses had been received from the Nurses' Board of Victoria.

Applications for approval for registration on October 28th, were:—General Register, by reciprocity, 28; Supplementary Part of the Register for Sick Children's Nurses, by reciprocity, 2; for Fever Nurses by Examination, 12, by reciprocity, 4. Total 46.

It was agreed that 69 nurses who had hitherto failed to pay their retention fee, and now wished their names re-included in the Register, should be re-included.

Education and Examination.

On the recommendation of the Education and Examination Committee, it was agreed that :---

The Leicester Royal Infirmary be now approved as a complete training School for Male Nurses:

The Wilson Hospital, Mitcham, be now approved as a complete training school for nurses;

The Schemes of affiliation between Liverpool Women's Hospital and St. Helen's Hospital, Warrington Infirmary, Southport General Infirmary, Royal Albert Edward Infirmary, Wigan, and Birkenhead General Hospital, be now fully approved;

The provisional approval of the Princess Beatrice Hospital, London, as a complete training school for nurses be extended for a further year :

be extended for a further year; The provisional approval of the Dartford Joint Isolation Hospital, as a complete training school for Fever Nurses be extended for a further year:

extended for a further year; The provisional approval of the Infants' Hospital, London, as a complete training school for Sick Children's Nurses, be extended for a further year :

be extended for a further year; The provisional approval of the scheme of affiliation between the Robert Jones and Agnes Hunt Orthopædic Hospital, Oswestry, and the Leicester Royal Infirmary, be extended for a further year;

The provisional approval of the scheme of affiliation between the Victoria Hospital, Deal, and the Royal Northern Hospital, London, be extended for a further year;

The provisional approval of the scheme of affiliation between the Caerphilly Isolation Hospital and the Cardiff

City Isolation Hospital be extended for a further year. It was agreed that the Council do have power at their absolute discretion to refuse to admit any person as a candidate for the Test Examination, without being under any obligation to state their reason for so doing.

Disciplinary and Penal Cases.

It was reported that the Council's Solicitor was instructed to take the necessary action under Section 8 (1) of the Nurses' Registration Act, 1919, against Aileen Sinclair who had falsely represented herself to be a registered nurse. Aileen Sinclair appeared at Crewe Police Court on October 5th, 1938, and was fined $\pounds 25$ or three months' imprisonment.
