5.—Describe in detail the care of the umbilical cord.

What complications may occur and what are your duties in these circumstances ?

6.-You have returned home after attending a normal confinement and receive a message that your patient is feeling faint. On arrival at the patient's house you find the patient pale, cold, and with a rapid pulse. Describe the examination you would make and the treatment you would give prior to the arrival of a doctor.
