THE PARROT CRY.

DEAR MADAM,—I recently attended a somewhat private meeting to discuss the burning question of the "Assistant Nurse," and frankly it would appear that highly qualified Registered Nurses know absolutely nothing of nursing economics and political economy.

A boss was in the Chair, and repeated the parrot cry that the "Assistant Nurse must be controlled." When we asked "by whom?" the reply was "By the G.N.C. of course." But why of course? I have been a Registered Nurse for twelve years and I was informed by Matron that the qualifying exams. were prepared on a minimum curriculum, and if I could not attain to the "simple standard" of the exams. my intelligence was exceedingly limited, as the standard was the minimum for safety of the patient. As far as I know, the minimum standard is still in force, and presumably the reason for thrusting untrained nurses on an ignorant public is that these women, many of them from elementary schools, are incapable of attaining the standard considered *safe* where the lives of the public are concerned. Then how dare the Inter-Departmental Committee propose to foist such attendants on sick people, because of course if they are registered or "rolled," the sick will vainly imagine they have been tested and approved by the Ministry of Health or the General Nursing Council (which ought to know better) or the College of Nursing, which is the villain of the piece in this matter. What amazes me is that the Minister of Health, who is apparently running this scheme with the College of Nursing, is a medical practitioner, and would not stand any such degradation in his own profession—rather not !—Yours, A GRATEFUL S.R.N.

A Rude Awakening,

At least the two Dictators do not pose as democrats, the while denying direct representation, free speech and justice to professional women concerning their own affairs. I predict a rude awakening should our dictators ruin our Register."

What I Have I Hold,

"In this land of appeasement I know war cries are not popular (more's the pity for Austria, Czechoslovakia, Memel, Bohemia and Moravia and Albania), but may I suggest we Registered Nurses adopt as our War Cry, on the suggested depreciation of Nursing Standards, "What I Have I Hold"? Would it be possible for those of us who have the courage to stand firm in opposition to the ruin of our Registration Act to wear an inscribed ribbon? People are inquisitive and an explanation of what the inscription means would be an excellent form of propaganda."
