### 13. Other business.

#### THE FLORENCE NIGHTINGALE INTERNATIONAL FOUNDATION,

The Grand Council of the Florence Nightingale International Foundation will meet in London on 10th and 11th July, 1939. At this meeting the Foundation will have to elect its officers, and, as a constituent member, the International Council of Nurses should submit nominations for the position of President of the Foundation, as the term of office of Dame Alicia Lloyd Still, who is now President, ends this summer.

The By-Laws (Trust Deed) of the F.N.I.F. provide that nominations for its officers should be sent in sixty days before the meeting, but as the Board meets only a week previously, this is not possible, and past experience proves that the constitution needs amendment in this particular.

Another point which it will be necessary to consider is the term of office of the F.N.I.F., which is two years, whereas the term of office of the I.C.N. is four years.

The presentation of certificates and also the annual dinner of the Old Internationals' Association will be held on the 6th July, and it is hoped that members of the Board of Directors, I.C.N., who will be in London at that time will attend these functions.

## THE NATIONAL COUNCIL OF NURSES OF GREAT BRITAIN.

#### SUB-COMMITTEE TO CONSIDER THE CONSTITU-TION OF THE NATIONAL COUNCIL OF NURSES OF GREAT BRITAIN.

The Sub-Committee appointed by the Executive Committee to consider the Constitution of the National Council of Nurses, met on May 10th, at 19, Queen's Gate, S.W.7, and there were present : Mrs. Bedford Fenwick, President, in the Chair; Miss S. A. Villiers, J.P., Hon. Secretary; Miss B. Monk, C.B.E., R.R.C.; Miss M. S. Cochrane, R.R.C., Miss G. V. Hillyers, Miss Isabel Macdonald, Miss H. McLoughlin, Miss E. Brodie, Miss M. M. Ingman, Miss R. Darbyshire, R.R.C., and Miss A. M. Bushby.

The President gave a short résumé of the founding of the Council in 1904, and its activities to date, and the Committee considered the Constitution clause by clause, but took no vote, as it was considered necessary to make definite recommendations as to the reorganisation of clauses after due consideration. It was agreed that the committee should meet for further consultation on Wednesday, June 7th, at 4 p.m.

The Sub-Committee met for a second time at 19, Queen's Gate, S.W.7, on Wednesday, June 7th. There were present Mrs. Bedford Fenwick, President in the Chair, Miss S. A. Villiers, Hon. Secretary, Miss B. Monk, C.B.E., R.R.C., Miss M. S. Cochrane, R.R.C., Miss G. V. Hillyers, Miss Isabel Macdonald, Miss H. McLoughlin, Miss E. Brodie, Miss M. M. Ingman, Miss R. Darbyshire, R.R.C.

Miss M. Breay and Miss A. M. Bushby were unable to attend.

The Articles of the Constitution were considered seriatim. A number of amendments were agreed.

# THE INFECTIOUS HOSPITALS MATRONS' ASSOCIATION,
