they did not report on their departments direct to their hospital boards, but their reports were submitted through their medical superintendents, who further had the right to discuss them. If, therefore, they upheld the right of the nurses to be trained in accordance with the curriculum of the General Nursing Council, while their medical superintendents insisted on training them for the examination of the Royal Medico-Psychological Association, the difficulty of their position was apparent.

Members of the Medico-Psychological Association who prepared pupils under their direction for the examination organised by their own Association, without explaining to them that it gave them no legal status, and that they would be ineligible when trained for many of the higher posts, unless they were State Registered Mental Nurses, adopted an indefensible and unethical position, and showed, moreover, disregard of the best interests of the pupils who relied on their advice.

The session concluded with cordial votes of thanks to the Chairman and speakers.

The Chairman reminded those present that the Interim Report of the Inter-Departmental Committee on the Nursing Services had been issued, and it was agreed that the Education and Examination Committee should meet on Wednesday, March 1st, to consider it, and also that the whole Council should consider it after the next meeting of the Council.

Correspondence.

From the Royal British Nurses' Association.

The Chairman reported the receipt of the following Resolution sent from the Royal British Nurses' Association, which was read to the Council by the Registrar :---

RESOLUTION.

That the Executive Committee of the Royal British Nurses' Association do express its strong disapproval of any suggestion for the extension of the powers and functions of the Nurses' Registration Act to give the recognition and protection of the State to any but the fully qualified nurses as now recognised under the Act. Such recognition (for nurses of inferior qualification), whether by placing them on a Register or on a Roll, would nullify in very large measure the value of the State Register, would lead to confusion and misunderstanding in the minds of the public, and would set the seal of the State's approval on inefficiency. Furthermore, such procedure would be tantamount to a breach of contract with the nurses now on the Register, because they have had their names placed thereon in the full assurance of the State's protection for their professional qualification.

DEAR MADAM,—The Chairman of the General Nursing Council has asked me to reply to your letter enclosing copy of a resolution passed by the Executive Committee of the Royal British Nurses' Association.

The Chairman desires to point out that the General Nursing Council has not received any request to set up a Roll of Nurses of inferior qualifications, nor have they received notice that it is the intention of the Minister of Health to extend the powers of the Nurses' Registration Act in the way suggested in the resolution.

The Chairman considers, therefore, that under the circumstances, the resolution at present would more appropriately be forwarded to the Minister of Health or the Inter-Departmental Committee on Nursing Services. Yours faithfully,
