## Duties of a Midwife During An Air Raid.

A request was received for a ruling as to the duty of a midwife in the event of an air raid occurring, and official instruction to seek cover being given, while she was proceeding to a confinement to which she had been called. The Board took the view that the issue of such a ruling was impossible since the matter is essentially one which must be decided by each individual midwife in accordance with common sense and in the light of the particular circumstances of the time.

### Use of Drugs by Midwives.

The Board was asked whether it was permissible for midwives to use a Michel clip for the repair of a slight superficial skin tear of scar tissue. The Board informed its inquirer that it regarded the repair of a torn perineum by a midwife as procedure outside her province, and that it could not agree to midwives being allowed to apply one or more Michel clips for such purpose.

### Administration of Drugs.

The Board informed the Medical Officer of Health of a local supervising authority that having regard to the dangers associated with the administration of protonsil and its derivatives, the Board regard such administration by a midwife, otherwise than under the direction of a registered medical practitioner, as treatment outside her

The Report of the work of the Central Midwives Board is of very great interest, not only to midwives but to Registered Nurses and the public at large, and no doubt a copy would be obtainable upon request to the Secretary.

#### Office of the Board.

On September 2nd, 1939, the office of the Board was moved temporarily to the building of the Ministry of Health while structural work was undertaken in the Board's own premises. The Board is grateful to the Ministry for the assistance thus rendered.

On January 23rd, 1940, the office returned to its premises in Great Peter Street. As a result of action by the local authority in renaming streets, the street number of the building had been changed in the interval. The present address of the office is 73, Great Peter Street, Westminster, London, S.W.I, R.A. The final letters "R.A." are important and should not be omitted when addressing communications to the Board.
