Disciplinary Cases.

Mr. Hewitt Pitt, Solicitor to the Council, placed the following cases before them:

Miss Edna Ruth Poole, S.R.N., 67433, was charged at the Birmingham City Police Court on July 30th, 1940, with stealing 100 tablets of morphia from the Aero factory, where she was engaged as nurse.

She pleaded overwork and an attack of influenza, and took the tablets for the purpose of committing suicide. After leaving the works, she put all the tablets down a drain in the road, and had taken none of them.

Miss Poole attended before the Council.

The Council considered the case in camera, and, although regarding the offence as a very serious matter, postponed judgment for a term of six months, Miss Poole to place herself under the care of a medical practitioner, and to send in a report at the end of that period.

Miss Mary Elizabeth Thompson, S.R.N., 50234, a member of the Private Nursing Staff of St. Thomas's Hospital, London, was charged at the South Western Police Court on August 16th, 1940, with obtaining heroin by forged prescriptions on 24 occasions, and discharged under the Probation of Offenders Act. The Matron at the Hospital, and the Superintendent of the Private Staff, the latter who attended with Miss Thompson, bore witness to her previous very good conduct and said they would have no hesitation in taking her back on to the staff.

The Council considered the case in camera, and while not minimising these crimes—forgery and taking drugs—both serious offences, had agreed to postpone judgment for a period of one year, Miss Thompson to remain under medical supervision and to keep the Registrar aware of her movements.

Miss Nancy Spencer, R.F.N. 9929, was charged at Uxbridge Petty Sessions with unlawfully obtaining £1 1s. from the post office. She was convicted, and bound over in the sum of £25 for 12 months, and fined £5 5s. costs.

The Council considered the case in camera and directed that the name of Miss Nancy Spencer be removed from the Register.

Application for Restoration of Name to the Register.

An application was considered from Miss Nathalie Pestereff for the restoration of her name to the Register, removed from the Register in February, 1939, for stealing goods to the value of iis. 6d. from Messrs. Harrods store.

Letters were read notifying the Council of the good conduct of Miss Pestereff before and since that time, and after considering the case in camera the Council agreed to re-include her name in the Register.

Next Meeting of the Council.

It was agreed that the next meeting of the Council be held on November 22nd, at the advanced time of 2 p.m.
