A SHORT REPORT BY THE PRESIDENT.

The President presented the following short report: After the declaration of war on September 3rd, 1939, it at once became apparent that members of the National Council of Nurses of Great Britain would be earnestly engaged in National Service throughout the country, and that representative meetings would be impossible.

"I, therefore, sent out a letter, together with the Audited Accounts, to the Hon. Officers and Presidents of all affiliated

associations, expressing this opinion.
"From replies, from the majority of those addressed, it was apparent that they were in favour of a cessation of activities, thus no meetings have been summoned since April 18th, 1939, and officers and committees have remained unchanged.

"No inconvenience has apparently been caused by this arrangement, as both National and International affairs

have received attention.

"Thirteen societies intimated approval, seven intimated that they were not wholly in favour of discontinuing meetings.

THE WORK OF THE SPECIAL SUB-COMMITTEE APPOINTED TO CONSIDER THE REVISION OF THE CONSTITUTION OF THE NATIONAL COUNCIL.

In a short statement on the appointment and work of the Special Sub-Committee appointed to consider the Constitution of the National Council of Nurses as a whole, and to make recommendations to the Executive Committee. it was reported that the Sub-Committee met at 19, Queen's Gate, on May 10th, June 7th and June 30th, 1939, and had agreed on numerous amendments.

The Chairman briefly referred to the recommendations.

A final meeting of the Committee to go carefully through the suggestions and draft its report to the Executive Committee was to have been held. This was not practicable owing to the outbreak of war.

The report was, therefore, not on the agenda for con-

sideration in detail.

But, broadly speaking, the Chairman reported that the recommendations suggested would entail considerable

Hitherto the finances of the National Council have been mainly a source of income in support of the International Council of Nurses, leaving but an infinitesimal sum available for national organisation, the work having been of a voluntary nature, made possible by the personal knowledge and devotion of the late Hon. Treasurer, Miss Margaret

The Chairman stated that before the National Council can be adequately financed, the high per capita fee to the International Council of Nurses must be reconsidered, and an income of at least £500 per annum available for conduct of business and general maintenance of the National

Council.

During the war no such policy is possible, but now that the voluntary organisers are passing away, they must be replaced in the future by an adequately remunerated staff. In the meanwhile, is it too much to hope that Registered Nurses in this country may take the trouble to qualify

themselves, as Miss Calista Banwarth is evidently doing in the International office, by acquiring sound knowledge of national and international history and procedure?

Some Members present were anxious that the meetings of the Executive Committee should be resumed, and it was proposed by Miss M. B. Monk, seconded by Miss R. E. Darbyshire, and agreed, that if circumstances permit three meetings be held in the year.

The Chairman informed the Committee that when the final meeting of the Special Sub-Committee had taken place and the Constitution had been re-drafted, a copy would be forwarded to each member of the Executive Committee for the consideration of the organisation she represents.
