Sir Arthur Stanley, G.B.E., C.B., M.V.O., LL.D., has resigned the position of Chairman of the Royal College of Nursing, a position he has held since the inauguration of the College in 1916, and there is no doubt that his social influence and support have been great assets in its progress, for which the members owe him sincere gratitude. Quite recently Sir Arthur expressed the opinion from the platform of the College that the nurses should manage their own affairs. As the Royal College of Nursing has been in active operation for a quarter of a century, we may presume that a Registered Nurse will now be elected to fill the vacancy.

The first meeting of the Civil Nursing Reserve Advisory Council was held at the Ministry of Health on Friday morning, April 5th. Miss Horsbrugh, Parliamentary Secretary to the Ministry of Health, was in the Chair.

Apparently the meeting was not open to the Press. The Royal British Nurses' Association, the first Association of Nurses in the world to receive a Royal Charter, has quite inexcusably been refused representation.

The Guild of Nurses also has been refused recognition, having been informed that it was represented through the National Council of Nurses. This is incorrect, as the Guild of Nurses is not affiliated to the N.C.N.

This policy of exclusion by a Government Department of Nurses' Organisations, which are entitled to express an opinion on national nursing affairs at this crisis, is, we presume, to be expected until the dictatorship at the Ministry of Health is superseded by a more liberal form of government.

In the meantime, untrained women of social influence, who, of course, have seats on the Council, will, we feel sure, consider themselves quite capable of conducting our professional affairs in connection with the care of the sick.

We are pleased to note that Mr. W. H. Harper, House Governor of the Royal Hospital, Wolverhampton, is a member of the Advisory Council. During his term of office on the General Nursing Council for England and Wales, he supported the best interests of the Registered Nurses in a very intelligent manner. No doubt he will use his sympathetic knowledge of the value of trained nursing upon the present occasion.
