## HELMETS FOR NURSES.

For some time the Managers of the Queen's Institute for District Nursing have been anxious that Queen's Nurses and Midwives, who have to run risks on duty from raids and bombs, should be provided by the Government with steel helmets. This would appear to be a national duty for the safety of these invaluable public servants. But no; for some time as usual the Ministry of Health "could not see its way." Then the public and *The Times* found no difficulty in doing so. Result, the following satisfactory information from the Ministry of Health Institute in reply to a letter to the Ministry of Health Institute, in reply to a letter to the Minister of Health.

Sir,—The attention of the Queen's Institute of District Nursing has been called to a letter in *The Times* of September 5th on the subject of the provision of steel helmets for district nurses. Representations on this subject have been made to the Ministry of Health from time to time, and a circular (No. 2124) has been received from them, stating that the subject had received consideration and asking local authorities to supply particulars of the number of helmets and respirators required for midwives and also for district nurses who are not midwives. It is hoped that this need will be supplied as soon as a sufficient number of helmets is available.

Nursing associations should therefore, apply to the scheme-making authorities of their county borough or area, stating the number of midwives or district nurses employed. In the case of those associations which are affiliated to the County nursing associations, the necessary steps will doubtless be taken by the County Associations on their behalf.

This matter has given very grave anxiety to the Queen's Institute and all responsible for the safety of midwives and district nurses, whose service to the community is now being carried on under such dangerous conditions, and we welcome the sympathetic decision of the Ministry in this urgent matter.
