# An Inaccurate and Unjustifiable Claim.

The Council of the College also took strong exception to an inaccurate and unjustifiable claim in the Journal used as its official organ, that the Royal College of Nursing "With no shadow of doubt, was instrumental in obtaining State Registration of Nurses."

In the opinion of the Council, and indeed in the opinion of all Registered Nurses who know the History of the Registration movement, this claim necessitated repudiation in justice to the life's work of our great pioneers, to whose devotion and generosity the Nursing profession owes its legal status. A disclaimer was therefore forwarded from the Council to the President and Council of the Royal College of Nursing.

## The Assistant Nurse,

Members of this College, recruited as they are from women of responsible thought and action, will realise that the burning question of the hour is the suggested State Registration of the semi-trained so-called "Assistant Nurse," advocated by the Association of Hospital Matrons, who largely control the training and economic stability of Student Nurses, and by the Royal College of Nursing, should receive the serious consideration of every Registered Nurse who values the privileges which she now enjoys under the administration of the Nurses' Registration Acts of 1919. This is a question which it is the duty of every Registered Nurse to carefully consider, when she cannot fail to realise the injury to the sick and the disastrous result to her professional status and well-being by such competition.

Such a principle would not be tolerated in any profession of men.

#### A New Constitution,

Owing to the demise and retirement of the two Trustees, a new Constitution for the College was considered and adopted, the details of which will be considered by the Council at a later date when the legal details have been agreed.
