NITROUS OXIDE AND AIR ANALGESIA.

Nature of prescribed instruction and conditions for approval of institutions for the provision of such instruction.

AMENDMENT OF REGULATIONS.

Hitherto the regulations have required that the course of instruction for midwives and pupil-midwives in nitrous oxide and air analgesia shall include the administration, by means of a recognised apparatus, of nitrous oxide and air analgesia to at least 20 patients in labour.

After consultation with the Royal College of Obstetricians and Gynæcologists the Board has decided to amend the regulations, for a trial period, by reducing the minimum number of patients to whom analgesia has to be administered from 20 to 15.
