between the Newark Town and District Hospital and Dispensary and the Nottingham General Hospital; between the County Hospital, Huntingdon and the Bolingbroke Hospital, London; between King George Sanatorium for Sailors, Liphook, and the Royal Portsmouth Hospital, and between the Birmingham Women's Hospital and the Royal Hospital, Wolverhampton, be extended for a further period of two years or for the duration of the war, whichever is the less;

Full approval of the Pre-Nursing Course at Brighton Municipal Secondary School for Girls be withdrawn, and that the course be now given provisional approval;

The one-year whole-time Pre-Nursing Course at Whalley Range High School, Manchester; at Canterbury Technical Institute, at Nottingham High School for Girls, at Pontefract and District Girls' High School, at Slough High School for Girls, and the two-year part-time Pre-Nursing Course at the Central School of Domestic Economy, Manchester, be approved for the purposes of Part I. of the Preliminary Examination.

# Disciplinary and Penal Cases.

It was reported that the Council's solicitor has been instructed to take action under Section 8 (1) of the Nurses' Registration Act against 11 persons who have falsely represented themselves to be Registered Nurses, and four of the cases have been dealt with.

#### Mental Nursing.

It was reported that Miss Willis has been elected chairman of the Mental Nursing Committee.

On the recommendation of the Committee, it was agreed that the provisional approval of Bridge Home, Witham, as a Training School for Male Nurses for Mental Defectives in combination with the Royal Eastern Counties' Institution, Colchester, be extended for a further period of two years, or for the duration of the war, whichever is the less.

#### Disciplinary Case.

The Council went in camera to consider the case of Irene Mary Godfrey, S.R.N., 82518 (deferred from Council on September 26th, 1941), and also the case of a Registered Nurse reported by the Police authorities, and information received concerning a Registered Nurse.
