LEGAL MATTERS.

NO POWER OF APPEAL.

The Nursing Profession has to thank Sir Waldron Smithers, M.P., for bringing the case of Miss Brownlow, S.R.N., before the House of Commons on more than one occasion.

"Sir W. Smithers (Chislehurst, U.) raised the question of the dismissal of Miss Brownlow, the matron of Farnborough Hospital, and said that here there was a prima facie case for an inquiry. Miss Brownlow was a lady of splendid character who had spent her whole life as a nurse, sister, and matron in the service of public assistance hospitals, and she was now dismissed at three months' notice. The Minister of Health, in a letter to him (Sir W. Smithers) on June 4th, wrote: 'No stigma attaches to the persons concerned. The appointment is terminated not because of misconduct or failure to discharge the duties attaching to the post, but because the post has ceased to exist or because its nature and its duties have undergone a fundamental change. . . I have also offered to sanction the payment to her of a gratuity of ± 500 , a step which is not usual in such cases, but which I regard as justifiable in this case in order to avoid any suggestion of ungenerous treat-The mere fact that the Minister of Health authorment. ised the payment of £500 to Miss Brownlow proved that there was nothing against either her character or efficiency.

"Mr. Brown said that the determination of Miss Brownlow's appointment was in no way connected with the inquiry of 1939, except so far as the strain of the inquiry might have made difficulties afterwards in terms of temperament. After the enlargement and change of function of the Farnborough Institution, when it became part of the London emergency casualty service, difficulties concerning the administration were brought to his notice by his officers in that service, and he would have been failing in his duty if he had not taken steps to secure the efficient working of that important key hospital. Miss Brownlow's original post ceased to exist when the Farnborough Hospital was taken over by the county council under the Public Health. Act, and the fact was that she had not been selected for appointment as matron of the enlarged casualty hospital or of the general hospital which it was projected it would become after the war. Replying to Mr. Ridley (Clay Cross, Lab.), Mr. Brown said he would do all he could to help Miss Brownlow to find a post which he thought was suitable."

The reply of the Minister of Health does not, of course, the whole story unfold. As matters stand, Miss Brownlow is discharged without a hearing, and the pension which should be due to her for her long service as Matron of the Farnborough Institution withheld.

Is it permissible for the Minister of Health, through a gift of $\frac{1}{500}$ of public money, to relieve the Farnborough authority of its responsibility in this particular? We think not.

We should advise Miss Brownlow to demand her pension if it is due to her, and to refuse in the meantime the solatium of £500, which certainly is not.

THE SCABIES ORDER.

One bit of advice may be useful in these times of overcrowding. Read the Scabies Order, issued by the Ministry of Health, and when out of doors do not fail to wear gloves; they are specially necessary when travelling. Also, unless you are anxious to pick up unconsidered trifles, keep your head free from contact with cushions. We travelled in a bus recently where apparently we were the only British Nationals, and where mops of black uncovered hair or greasy ringlets were apparently de rigueur.
