THE GENERAL NURSING COUNCIL FOR ENGLAND AND WALES.

A meeting of the General Nursing Council for England and Wales was held at the offices of the Council, 23, Portland Place, London, W., on January 22nd.

Election of Chairman.

The Countess of Limerick, representative of the Privy Council, announced that Dame Ellen Musson had been nominated by 14 members of the Council to act as Chairman during 1943; there was no other nomination. Dame Ellen Musson took the chair, and said she would continue the duties as well as she could while her colleagues were so busy during the war.

Election of Vice-Chairman.

Miss D. M. Smith was nominated by 13 members of Council to hold office as Vice-Chairman during this year; there was no other nomination. The Chairman congratulated Miss Smith, on behalf of the Council, upon the award she had received in the New Year Honours.

Business Arising out of the Minutes.

The Chairman announced that the Minister of Health approves the appointment of a second Assistant Registrar, at the same salary as the Assistant Registrar.

A rule for candidates sitting for the examinations was considered, and it was agreed, after some discussion, that it be placed upon the Agenda for the next meeting of the Council.

Finance.

On the recommendation of the Finance Committee, bills and claims submitted for payment were approved, and the sums of £840 for weekly salaries, £100 for postage, and £50 for Insurance stamps allowed.

Registration.

Applications for approval for Registration were : General Register, by examination, 6; by reciprocity, 8; Supplementary Part of the Register for Mental Nurses, by reciprocity, 2; for Sick Children's Nurses, by reciprocity, 1; for Fever Nurses, by examination, 12; by reciprocity, 3. Total, 32.

On the recommendation of the Registration Committee, it was agreed that 58 nurses who had hitherto failed to pay their retention fee, and now wished their names reincluded in the Register, should be re-included. It was reported that the Register of Nurses for 1942

has been received from the Association of Registered Nurses of the Province of Quebec.

Education and Examination.

Approval was given in respect of Hospitals as Training Schools, and Pre-Nursing Courses were also approved.

Disciplinary and Penal Cases.

The Solicitor to the Council presented the case of Amy Elizabeth Button, S.R.N., 11,002, to the Council.

Miss Button was reported as being intoxicated while on duty; leaving a helpless patient on the floor for half-anhour; discontinuing medicine of a patient for some weeks, while on duty at the Glazebury Nursing Home, London.

A former patient, and the Matron of the Home, appeared and gave their evidence before the Council.

The Council considered the case in camera, and the Registrar was directed to remove the name of Amy Elizabeth Button from the Register of Nurses.

The case of Irene Ethel Robinson, S.R.N., 107,883 (deferred from Council on January 23rd, 1942), was considered in camera, and the case dismissed.

Application for Restoration of Name to the Register.

Application by Miss Margarethe Charlotte Grosset for the restoration of her name to the Register, removed in 1940, was considered *in camera*, and the Registrar was directed to re-include the name of Margarethe Charlotte Grosset in the General Part of the Register, and issue to her a new Certificate of Registration.
