## THE GENERAL NURSING COUNCIL FOR ENGLAND AND WALES.

A meeting of the General Nursing Council for England and Wales was held at the offices of the Council, 23, Portland Place, London, W., on September 26th. Miss D. M. Smith, Chairman, presided.

Dr. H. M. C. Macaulay was congratulated upon his appointment as Chief Medical Officer, North Western Metropolitan Region.

It was reported that the Minister of Health has noted with regret the action of British Columbia; the Report of the Working Party is being considered by the Minister of Health.

It was reported that in future the Rules of the General Nursing Council will be governed by the Statutory Instrument Act; will be printed by H.M. Printers and sold to the public from H.M. Stationery Office.

## Finance

On the recommendation of the Finance Committee bills and claims submitted for payment were approved and the sums of $£ 2,100$ for Weekly salaries, $£ 500$ for Postage and $\ddagger 30$ for Petty Cash were allowed.
Stationery estimates to the value of $£ 19810 \mathrm{~s}$. 8d. for Assistant Nurses Committee election were agreed ; $£ 2,696$ 8s. 10d. for printing 150 copies of Roll of Assistant Nurses ; $£_{194} 7 \mathrm{~s} .7 \mathrm{~d}$. for Stationery ; and $£ 1726 \mathrm{~s} .6 \mathrm{~d}$. for Examinations Stationery.
It was agreed that a fee of 75 guineas be paid to the Returning Officer for conducting the forthcoming Assistant Nurses Committee Election.

## Registration

Applications for Registration were: General Register by reciprocity 80 ; Supplementary Part of the Register for Nurses for Mental Diseases by reciprocity 17; for Sick Children's Nurses by reciprocity 9; for Fever Nurses by reciprocity 51 ; by examination 27 ; total 138.

It was agreed that 143 nurses who had hitherto failed to pay their retention, and now wished their names reincluded in the Register, should be re-included.
It was reported that applications from 313 Nurses for Certificates of Registration as Sister Tutors have been found to be in order.
It was agreed that an asterisk be placed against the entry in the General Part of the Register, and in the Part of the Register for Male Nurses, as the case may be of each applicant, denoting that she has received a Certificate of Registration as a Sister Tutor.
It was agreed that the provisional approval accorded by the University and the Council to the course of training for the Sister Tutor's Diploma of the University of London provided by King's College of Household and Social Science in the session $1946-47$ be confirmed; that the course be approved for a further period of five sessions, viz., 1947-52; and that Registered Nurses who obtain the Sister Tutor's Diploma of the University of London on completion of such courses be entitled to receive from the Council a Certificate of Registration as a Sister Tutor.
Approval was granted to Hospitals as Training Schools, pre-nursing courses were approved.

## Mental Nursing

Correspondence with the Royal Medico-Psychological Association regarding the delay in implementing the agreement between the Association and the General Nursing Council was considered, and various questions were raised by members of Council.
The draft letter to the Minister of Health concerning this matter was amended and agreed.

## Assistant Nurses

Hospitals as Training Schools for Assistant Nurses were approved.
It was agreed that the names of the 1,147 applicants, whose applications have been found to be in order, be entered in the Roll of 'Assistant Nurses.

## Disciplinary Cases

The case of Elizabeth Joan Brixey, R.M.N. 9405 was considered, and judgment was postponed for six months.
The case of Etheldene Gwladys Rees, S.R.N. 56596 was considered, and judgment postponed for one year.
