Election of Fellows and Members

Applications were received for Fellowship and Membership of the British College of Nurses, Ltd., and all were accepted.

The meeting then terminated.

A Meeting of the League of Fever Nurses, was held at 194, Queen's Gate, London, S.W.7, on Saturday, January 25th, 1947, at 2.30 p.m. The President, Miss N. Dunkley, S.R.N., was in the Chair.

The meeting was well attended and a large amount of business was dealt with. Satisfaction was expressed that the Hon. Secretary, Miss H. McLoughlin, had been elected the Delegate of the League of Fever Nurses, to attend the International Congress of Nurses, to be held in Atlantic City, U.S.A., in May this year.

After a lively discussion on the position of Registered Fever Nurses, it was unanimously agreed, that to stand firmly for professional independence is the policy of the

League of Fever Nurses.
