tions be appointed by the Minister as "assessors" to attend meetings of the Mental Nursing Committee of the Council and express their views and offer advice, such persons to have no voting rights on the Committee.

#### Disciplinary Case.

The case of Miss Gertrude Mary Hill, S.R.N. 91268, was brought by the Council's Solicitor. She pleaded guilty to having unlawfully procured dangerous drugs while on the staff of the Ilford Maternity Home, where she was found in a collapsed condition with broken phials in her possession. Her case had been discharged from the Court of Summary Jurisdiction at Stratford.

The Chaplain of the Oldchurch Hospital, Romford, accompanied Miss Hill to the Council meeting, where he spoke of the good work Miss Hill had given to that hospital during the war years when she had held the post as Night

The Council considered the case in camera, and it was agreed that the Council postpone judgment for the period of one year on the facts proved against Miss Hill.

We realise the gravity of this case and what it entails, nevertheless we are somewhat mystified concerning the judgment of two cases brought before the Council at two consecutive meetings, when the Registrar was directed to remove the name of one offender from the Register, and at the following meeting another Registered Nurse, found guilty of a similar offence, was given postponed judgment for one year.

Is it the case that the one nurse who was accompanied to the Council meeting by someone to plead for her was treated with more leniency?

It is only in the cause of justice that this question
