The numerous nurses whose long hours on their feet, coping with extra duties owing to staff shortages, cause them to consult chiropodists, have been pleased at the urgings of the South African Association of Chiropodists that the Government should legislate against unqualified practitioners. The Association disapproves of the activities of "quack specialists in foot ailments."

Chiropodists with recognised qualifications register voluntarily with the South African Medical Council.

According to the Association's secretary, abstention from displaying a certificate recording such a registration usually speaks for itself. Unskilled treatment is declared to have been causing much suffering.
