# The General Nursing Council for England and Wales.

A MEETING OF THE GENERAL NURSING COUNCIL for England and Wales was held at the offices of the Council, 23, Portland Place, London, W., on April 28th. Miss D. M. Smith, O.B.E. Chairman, presided.

# Business Out of the Minutes.

It was reported that a further sum of £25,000 had been invested in British Transport 3 per cent. Stock.

#### Nominations for Vacancy on the Council.

It was reported that Miss J. M. Loveridge, S.R.N., Matron, St. Bartholomew's Hospital, London, and Miss E. M. Wearn, S.R.N., Superintendent, Queen's District Nurses Home, Leytonstone, had been nominated to fill the vacancy on the Council caused by the resignation of Miss C. A. Alexander. A ballot was taken and Miss Loveridge was successful.

#### Finance.

On the recommendation of the Finance Committee, bills and claims submitted for payment were approved and the sum of  $\pounds4,550$  for weekly salaries and Inspectors' expenses (for five weeks) was allowed.

It was agreed that 10 six-drawer wooden filing cabinets be purchased for the Assistant Nurses Department at the cost of £96 15s. 0d., 25 steel filing boxes at a cost of £19 2s. 10d. be purchased for the Examinations' Department, and that an estimate of £47 14s. 10d. be accepted for 1,000 copies of List of Persons admitted to and removed from the Roll of Assistant Nurses during the period, May to August, 1950.

# Names Removed from State Register of Nurses.

It was reported that the names of 16,062 General Nurses, 147 Male Nurses, 1,329 Mental Nurses, 136 Nurses for Mental Defectives, 962 Sick Children's Nurses and 3,242 Fever Nurses, had been removed from the Register of Nurses for failure to pay the Consolidated Retention Fee; and 243 names were removed from the List of Names for the same reason.

#### General Purposes.

It was reported that Miss A. W. Cameron, Assistant Examinations Officer be appointed to the post of Examinations Officer, upon the resignation of Miss V. Robinson.

It was agreed that the sum of £8 8s. 0d. be paid for replenishing soil in window boxes, and that £98 per annum

be spent on four displays a year for nine window boxes. It was agreed that £99 15s. 6d. be spent on fluorescent pendant fittings for the improved lighting in the Kardex room.
